2012 Chairman's Report

Hello to all the hunters taking time to read this report. 2012 has been significant in the history of Woodhill forest as the ownership has passed from the Crown to Ngati Whatua O Kaipara as part of the Treaty of Waitangi settlement process. What this means to the WMFC is not clear at this stage be we are hopeful we can have a good working relationship with Ngati Whatua and continue to manage the fallow deer herd and provide public hunting into the future in Woodhill forest.

In March of this year the then Chairman of the WFMC, Ross Tindale, accepted employment in Napier and subsequently resigned his role as Chairman. I have stepped in as acting Chairman until the next AGM. I would like to thank Ross for his valuable contribution to the WFMC during his tenure as both a committee member and as Chairman. I wish him and his family well with their new life outside of Auckland.

I would also like to thank the Committee for the hundreds of hours they put in each year to make the Woodhill Ballot a success.

The number of animals seen and shot this year has been on a par with other years. Managing the deer herd to maintain a stable population is not an easy task for the committee. There are always deer shot on the neighbouring farms and illegally in the forest making it hard for the WFMC to accurately estimate the herd numbers. The amount of food available is somewhat determined by the tree harvesting cycle in the forest. After the trees have been felled and the next cycle of young pines planted there are large areas with an abundance of food for at least five years. Once the young pines get to about 6-7 years of age they start to block out the light reaching the ground and the grass and lupins die off and the deer move to new areas.

One of the options we are looking at in managing the herd is the possibility of every 3 or 5 years having a moratorium on shooting bucks for that year. This would allow some of the bucks a chance to grow a better set of antlers and possibly be more hunter wise. This year probably around 80% of the bucks shot were only 2 year olds. So on the year when there is a buck ban only doe permits will be issued. Hunters would then have the option of entering the ballot draw with the chance of getting some meat or not hunting that year. We would like to hear hunter feedback on this proposal.

It is interesting to note that most hunters report seeing numerous does on their hunt. This year as with previous years we issued around 260 doe permits resulting in only 61 does being shot which brings me to the conclusion that either we have a lot of inexperienced hunters getting doe permits or hunters are hunting too fast or being too noisy or both and are spooking the animal before they could get a shot at it.

Another change for the 2013 season is that all hunters must wear a **PLAIN BLAZE ORANGE VEST WITH NO CAMMO PATTERN** on it. The last 3 hunting fatalities in NZ the hunters have been wearing orange vests but have still been shot and it has been suggested that the cammo pattern detracts from the effectiveness of the blaze orange especially in thick bush. The WFMC has a 100% safety record and we don't want to jeopardize this. While on this subject a common report from Patrols this year is the lack of firearm safety displayed by hunters when approached by a vehicle or Committee member. Please ensure your rifle is pointed in a safe direction, the rifle is unloaded and the action open. Hunting rifles can kill, they are not paint ball guns, nerf guns or water pistols. There seems to be a lax attitude to firearm safety amongst some of the hunters.

In the past the WFMC has given away three \$120 spot prizes of names drawn out of the successful ballot hunters who have sent in kill returns. For the 2013 season we are changing that to a new competition. We will be giving two \$100 prizes to the best story from a Woodhill hunt and two \$100 prizes for the best photos taken on a Woodhill hunt. The photos need not be of a successful hunter they may be of human interest or of flora or fauna. So don't forget to take your camera and put pen to paper.

Added to the website (www.fallowdeer.co.nz) this year is a Youtube link to a TV Wild episode the Graf boys filmed in Woodhill and it gives a good overview on the role of the WFMC and the deer in Woodhill Forest.

- Read the rules
- Have a map of the block
- Are wearing a plain blaze orange hunting vest
- · Have a firearms licence on their person while hunting

COMPLETING YOUR APPLICATION

- ~ Always write details in plain legible English, if your application is unreadable it will be rejected before ballot.
- ~ Ensure your mailing address is correct, if it changes let us know. If changes are not notified it may not be possible to contact you.
- ~ If you are successful in ballot (i.e. Have received postal notification) complete and return form by due date. If the returned form is not received by due date block will be reallocated.
- ~ If you are successful in ballot and you can't make it let us know immediately so that we can allocate date to another hunter.

~ You must sign acceptance of rules and conditions on the ballot application otherwise application is not complete and WILL NOT be accepted!!!

What you can do to make the administration of your hunting permit easier and smoother.

All correspondence should be by the primary permit holder, unless sickness or overseas travel restrict their ability to do so.

If you have a problem, you think I can sort out, the sooner you contact me the better.

All phone messages/ calls should state the date of your hunt and allocated block and your name, then what the call is about. I always return calls where possible. Ensure your phone numbers are correct on your return and application forms. If you don't leave a detailed message I can't prepare an answer for you, which wastes time.

Doe permits, write on left of name as stated, as when loading data on to computer its easiest when all returns are the same to read. You wouldn't want me to miss the fact you wanted a doe permit.

Postal address, please ensure you put your post code on all correspondence with us.

Ten percent of returns, that's 25 out of 250 are incorrectly filled out, please take the time to read information sent to you before you start filling in the return. Double check your return to ensure you have covered every requirement. You only have to check one return, I have to check 250!!

- ~ A plain Hi Viz blaze orange vest must be worn on top at all times, regardless of what else is being worn.
- ~ No smoking in Forest
- ~ Replacement of hunter on permit, only on acceptance (payment) date.
- ~ All hunters to sign indemnity clause.
- ~ One hunt per hunter each year.
- ~ Firearms license must be current and carried while hunting
- ~ Vehicles to have current W.O.F. and registration when entering forest
- ~ No camping in forest or access roads.
- ~ No shotguns, rimfire firearms or rifle suppressors
- ~ Successful applicants notified by mail.
- ~ Permits must be displayed on dashboard of all vehicles

Patrols Report

The 2012 season was relatively trouble free. The main problem this year being when the radios went down due to a colony of ants deciding to build a nest in the base of the repeater. There were the usual reports of motor bikes in some of the blocks but not as many as other years. Also the odd four wheel drive. If you do come across a vehicle in your block please try and get a registration number and give it to the patrol people. All the access gates survived the season unscathed so that was a bonus.

If for some reason you are unable to hunt on your allocated day ring the number on your information sheet as soon as possible. There are many others we can re allocate your block to.

If your party is in more than one vehicle make sure a copy of your permit is displayed on each dashboard, in case of an emergency we need to be able to account for all vehicles.

During the day the patrol people sometimes pick up hunters and drop them off at their vehicles or give them a ride back to their blocks. If you are offered a lift make sure your rifle is unloaded and show it to the driver, safety is paramount. Also when you get out of the vehicle take all your gear with you, it makes it easier all round. Talking about safety we have been increasingly concerned about what some hunters consider to be a high visibility vest. We have seen hunters wearing dull orange and camo vests which from a safety point of view are useless. A full size plain hi viz orange vest stands out above any other material. Don't let anybody convince you otherwise. It is one of the conditions of your permit that you must wear a high viz orange vest. Your safety while hunting in Woodhull Forest is paramount [or anywhere else for that matter].

Because of our concerns, from 2013 on all permit holders hunting in Woodhill Forest will be required to wear a full HIGH VISIBILITY FLORESCENT ORANGE VEST. No MINI vests. No CAMO vests. No COMPROMISE. There should be no concerns over this as it is for your safety, however if you have any questions contact the Woodhill Committee.

Hunter Safety: A timely reminder

The following rules are easily recognisable to Hunters who take advantage of the hunting opportunities the Woodhill Fallow herd provides through the W.F.M.C hunting ballot.

After all, every hunter has had to apply for a firearms license and learn the seven basic rules of firearms safety.

Rule 1: Treat every firearm as loaded

Rule 2: Always point firearms in a safe direction

Rule 3: Load a firearm only when ready to fire

Rule 4: Identify your target beyond all doubt

Rule 5: Check your firing zone

Rule 6: Store firearms and ammunition safely

Rule 7: Avoid alcohol and drugs when handling firearms

Previously the following actions have been observed and reported by the patrols:

1. Hunters failing to correctly identify their target beyond all doubt.

The council has had to deal with a number of hunters who failed to comply with their permits and shot the incorrect animal.

2. Always point firearms in a safe direction

Please don't use a rifle mounted telescopic sight to

A. Check out your hunting companions

B. Check out the patrols driving the roads

C. Check out the hunters on adjacent blocks

A small pair of binoculars doesn't add too much weight to your daypack and will increase your chances of success.

3. Load a firearm only when ready to fire.

When approached by a patrol, or anyone else, all hunters should empty the breech and leave the bolt or action open. While the patrols will assist you in returning to your car, hopefully after a successful hunt, or stop and provide advice if needed, it is not unusual to have to ask hunters to unload their rifles before entering the patrol vehicle.

The W.F.M.C. Balloted hunting has an impeccable safety record.

This is as much due to you the hunter as to the efforts of the committee.

Let's keep it that way.

The Top Ten Reasons Why You Missed Out On a Ballot at Woodhill

Every year we get people writing in and telling us they have never won a ballot at Woodhill in the last ten years. Statistically if you and two of your mates each put in a ballot the odds of having a hunt are around 1 in 3 or a 33% chance each year. However each year people exclude themselves from the ballot because of various reasons. Here is a list of the top 10.

- 1. You have been trespassed in Woodhill Forest or any other forest in New Zealand managed by Hancock Forest Management (HFM). We submit a list of all successful ballot winners to HFM which is checked against their database.
- 2. You were the primary ballot holder for a hunt the previous year and you did not submit a Sighting/Kill return by the 1 October read the rules
- 3. Your ballot was successful and the ballot acceptance advice was sent to the address on the ballot application but was returned because you have shifted leaving no forwarding address.
- 4. Your ballot was drawn however your writing was so illegible that despite being checked by several scrutineers we could not decipher your address. All on- line applications can be typed.
- 5. You have deposited your ballot fee into our account by direct credit but have not sent in the ballot form. This accounts for a number each year.
- 6. You put down your Drivers Licence number instead of your Firearms Licence number. Perhaps you need glasses or else how will you identify your target?
- 7. You don't have a firearms licence or you provide an incorrect firearms licence number
- 8. You have not signed your application. This one is a big one; you are signing the application form to tell the WFMC that you have read and understand our rules and agree to abide by them. If you can't do this we don't want you on one of our hunts.
- 9. On a previous hunt at Woodhill you or one of your companions has broken one or more of the Rules of the WFMC. There is always the few who spoil it for the many. This is generally hunting without a blaze orange vest, hunting outside your block, shooting an animal you don't have a permit to shoot or shooting from the road.
- 10. Your ballot gets drawn, you are sent your ballot acceptance advice but you fail to sign it and return it by the due date.

There are a few others like bounced cheques, insufficient postage notification and so on.

In most cases we will try and contact the applicant by phone or email but again some applicants don't leave valid phone numbers or don't respond to any messages that were left.

Read the application form thoroughly, read the rules, remember to fill out every requirement and sign the ballot application form. Please remember we are a small team of volunteers and not some big corporation so try and make our job easy.

TAKE A KID HUNTING REPORT

The 2012 TAKH day took place on 15th September, the last day of the WFMC hunting season under the lease arrangement between the Council and Hancock's Forest Management Ltd.

The day began with a welcome by the Chairman Garth Johnson who outlined the day's activities. He also welcomed Clyde Graf who was filming the event for his and his Brother Steve's Wild New Zealand programme. Two Officers from the New Zealand Police (both hunters) spoke on firearm licensing and safety with an emphasis on the seven rules of firearm safety. They also outlined their anti poaching initiative which with their positive results will help make Woodhill a safer and better place to hunt.

Participants then sat the standard NZ Police Firearm License test, the results of which established the order of the block selection. Hunter Safety was again emphasized by the talk given by Rick Linton, a hunting accident survivor. Further informative talks were delivered by Mark Nobilo and Brian Witton on Hunting techniques and herd dynamics which kept the kids interested right up to the BBQ Lunch of venison and venison sausages, thanks to the cooks.

The hall was suitably decorated with a number of record book trophies across a wide spectrum of New Zealand's game animals including the 3 best fallow buck heads from the Kaipara herd. A big thanks to those hunters who kindly lent their trophies for the day.

Four deer were taken by the aspiring hunters who were rapt with their success and their thank you letters received by the committee post hunt were greatly appreciated.

On Saturday 15th September I went to TAKH with my Dad. We had a great morning listening to the many guest speakers on firearm safety, hunting techniques and the history of the fallow herd in Woodhill.

After a BBQ of venison sausages, we were allocated our hunting blocks and set out to try our luck. We were given Block 8A and Brian dropped us off at the start of a track he suggested I try. We followed the track up and around the bottom part of the block then cut up through the middle. Dad said to load the magazine and close the bolt on my empty chamber. While walking very slowly up the track that was cut over and had small pines I saw plenty of fresh deer prints in the sand.
